Product Overview

Drug Knowledge's proprietary Drug Informational Databases make up the Comprehensive Medication Counseling Database (CMCD)[™]. The CMCD contains over 220,000 unique NDCs (Rx and OTC) with patient information coded to the dosage form and route of administration. The CMCD[™] includes the following databases:

■ Mini-Medication Messages

Short descriptors with graphical depictions used as reminders of:

- How to take.
- When to take.
- Under what circumstances certain products/foods should be avoided.
- Possible side effects to mention and watch out for.
- Example to left: Atorvastatin (Lipitor)

Mini Medication Messages serve as a reminder to the patient of the advice given by the pharmacist or health care provider during their drug consultation session.



■ Patient Medication Advisories Databases (Rx and OTC Items)

A more in-depth document, written in layman's terms, that addresses the following:

- Name of the medication prescribed (brand and/or generic name).
- What the medication is used for.
- Proper use (how and when to take/administer).
- Important information to remember: what to avoid, etc.
- Possible side effects.
- Missed dose instructions.
- General information for all medications.

■ Therapy Monitoring Monographs

This information will assist pharmacists, medical, and nursing staff in monitoring patient/residents for signs and symptoms of Adverse Drug Reactions. The information presented includes:

- Name of the medication being administered (generic and/or brand).
- How to Administer: short concise statement(s).
- Possible adverse reactions.

Possible Use: This information has been designed to fit on the various punch cards utilized by pharmacists when they dispense medications for patients residing in various facilities; i.e., assisted living facilities, group homes, correctional facilities, nursing facilities, or patient homes when residing with a care giver.

Features & Options

The CMCD[™] contains over 220,000 unique NDCs (Rx and OTC) with patient information coded to the dosage form and route of administration. The CMCD[™] can be licensed and incorporated into various software platforms such as electronic medical records (EMRs), medical/pharmacy software, as well as mobile applications — wherever patient drug information is needed.

All databases are developed, maintained, and reviewed by a team of healthcare professionals. Updated as new drugs, dosage forms or new information is released and approved by the FDA on existing medications. Drug Knowledge's databases are written and designed for the patient; meaning the databases can be used by any healthcare professional during a medication counseling session with their patient, or presented to the patient for them to read in the leisure of their home.
