Advasur and PRS are DSCSA service and solution leaders and stand ready to serve dispenser pharmacies for full compliance with current and future DSCSA requirements with minimal disruption to business workflow operations and patient care.

At the tail end of August 2023, the FDA announced a one-year stabilization period where they announced they did not plan to take action to enforce various aspects of the Enhanced Drug Distribution Security (EDDS) requirements (582g) of the DSCSA until 11/27/2024. This guidance did not affect the existing requirements currently in place today under the DSCSA requirements.

The FDA expects pharmacies (and all trading partners) to use this stabilization period to build and validate interoperable systems and processes, manage products and data, and ensure patient

supply chain continuity and product availability. This period is not intended to provide, and should not be viewed as providing, a justification for delaying efforts to comply with the DSCSA.
